

**CITY OF SEVERY, KANSAS
CHARTER ORDINANCE NO 8**

A CHARTER ORDINANCE EXEMPTING THE CITY OF SEVERY, KANSAS, FROM CERTAIN PROVISIONS OF K.S.A.12-4105 AND 12-4112, RELATING TO IMPOSITION AND COLLECTION OF MUNICIPAL COURT COSTS AND COMPENSATION OF MUNICIPAL JUDGES, AND PROVIDING SUBSTITUTE AND ADDITIONAL PROVISIONS ON THE SAME SUBJECTS.

WHEREAS, K.S.A. 12-4105 and K.S.A. 12-4112 are part of the Kansas Code of Procedure for Municipal Courts, K.S.A. 12-4101, et seq., which Code does not apply uniformly to all cities in the State of Kansas; and

WHEREAS, the City of Severy, Kansas, hereby elects to exempt itself from certain provisions of K.S.A. 12-4105 and K.S.A. 12-4112 pursuant to its home rule powers as set forth in Article 12, Section 5, of the Constitution of the State of Kansas, and to provide for substitute and/or additional provisions on the same subjects;

NOW THEREFORE: Be it proclaimed by the Governing Body of the City of Severy, Kansas:

Section 1: In lieu of the requirements in K.S.A. 12-4105 and any amendments thereto which require monthly or annual salary payments, the municipal judge shall be compensated in amounts and intervals to be set and adjusted from time to time by resolution of the Governing Body.

Section 2: In lieu of the provisions of K.S.A. 12-4112 and any amendments thereto which prohibit the City of Severy, Kansas from imposing and collecting court costs, the Governing Body is authorized to adopt by regular ordinance a schedule of court costs and fees to be charged and collected in all actions and cases filed and docketed in the Municipal Court of Severy, Kansas.


Section 3: All court costs and fees provided by this Charter Ordinance are to be collected by the Municipal Court and then paid into the General Fund of the City of Severy, Kansas.

Section 4: This Charter Ordinance shall be published once each week for two consecutive weeks in its official city newspaper, and it shall become effective sixty-one (61) days after its final publication. Provided, however, that it shall not take effect if, within sixty (60) days of its publication, a petition signed by no less than ten (10) percent of the number of electors who voted in the last preceding regular election shall be filed in the Office of the City Clerk of Severy, Kansas, demanding that such ordinance be submitted to the vote of electors, in which case it shall not take effect until submitted to the vote of the electors and approved by the majority of the electors voting thereon.
